AN ORDINANCE REGULATING AND LICENSING TAVERNS IN THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AND AMENDING "AN ORDINANCE REGULATING AND LICENSING TAVERNS IN THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS", PASSED AND APPROVED THE 26TH DAY OF FEBRUARY, A. D. 1946.

BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF BELLEVUE, Peoria County, Illinois, as follows:

SECTION 1. A Tavern is hereby defined to be any place within said Village where Malt, Vinaceous, Alcoholic or Intoxicating Liquors are sold or offered for sale at retail for consumption on such premises. Taverns, as herein defined, are hereby classified into two classifications, namely Class A Taverns and Class B Taverns. A Class A Tavern is hereby defined to be any Tavern licensed within the VILLAGE OF BELLEVUE to remain open for the hours, as provided for such Class A Tavern in Section 8 of this Ordinance. A Class B Tavern is hereby defined to be any Tavern licensed within the VILLAGE OF BELLEVUE to remain open for the hours, as provided for such Class B Tavern in Section 8 of this Ordinance.

SECTION 2. It shall be unlawful for any person, firm or corporation, either directly or indirectly, by himself, herself or itself or through any Agent, Servant or Representative, to operate or conduct any Tavern or Tavern Business within the corporate limits of the VILLAGE OF BELLE-VUE without first obtaining a License to so operate such Tavern or Tavern Business or without complying fully with the terms and provisions of such License when issued.

SECTION 3. No more than three Class A. Taverns or Tavern Businesses and no more than one Class B Tavern or Tavern Business shall be operated within the said VILLAGE OF BELLEVUE at any one time.

SECTION 4. The President of the Board of Trustees of this Village is hereby authorized to issue Tavern Licenses in compliance with the terms and provisions of this Ordinance upon written application made to him, signed by the persons, firms or corporations owning such Tavern or Tavern Business, provided, however, that said Application shall be made at the Office of said President of the Board of Trustees of this Village within such hours as may be designated by him to be his office hours and provided, further, that the Applicant for such License shall pay, in cash, to the said President of the Board of Trustees of said Village at the time his application is made and prior to the issuance and delivery of such License, the proper License Fee for such License.

SECTION 5. Tavern Licenses, regardless of Class, may be issued annually, that is, for a period of one (1) Calendar Year; or Quarterly, that is, for a period of three (3) Calendar Months. An Annual Tavern License shall be issued only for a period commencing January 1st of any one Calendar

Year and ending December 31st of the same Calendar Year. No Quarterly Tavern License shall be issued except for Quarters of the year commencing January 1st and ending March 31st, both inclusive, commencing April 1st and ending June 30th, both inclusive, commencing July 1st and ending September 30th, both inclusive, and commencing October 1st and ending December 31st, both inclusive.

SECTION 6. The Annual Tavern License Fee shall be \$400.00 for Class A Taverns and \$600.00 for Class B Taverns. The Quarterly Tavern License Fee shall be \$100.00 for Class A Taverns and \$150.00 for Class B Taverns. No discount shall be granted any applicant for any annual license applied for after the beginning and before the end of any annual period, as herein defined, nor for any quarterly license applied for after the beginning but before the end of any quarterly period, as herein defined, and no refund shall be allowed to any Licensee for any license discontinued, revoked, abandoned or otherwise unused within the period for which the same may be issued nor for any other reason.

SECTION 7. No Tavern License, issued under the provisions of this Ordinance or any interest of any kind therein, shall be sold, transferred, assigned or otherwise disposed of, in any manner or way, to anyone but the Licensee to whom the same is issued except as provided by and in compliance with the laws of the State of Illinois, in such cases made and provided.

SECTION 8. All Class A Taverns within the VILLAGE OF BELLEVUE shall close promptly at the hour of 2:00
o'clock A. M. and remain closed constantly until the hour
of 6:00 o'clock A. M. on Monday, Tuesday, Wednesday, Thursday, Friday and Saturday of each week and shall close promptly at the hour of 2:00 o'clock A. M. and remain closed constantly until the hour of 1:00 o'clock F. M. on each Sunday
of each week. All Class B Taverns within the VILLAGE OF BELLEVUE shall close promptly at the hour of 4:00 o'clock A. M.
and remain closed constantly until the hour of 6:00 o'clock
A. M. on Monday, Tuesday, Wednesday, Thursday, Friday and
Saturday of each week and shall close promptly at the hour
of 4:00 o'clock A. M. and remain closed constantly until the
hour of 1:00 o'clock P. M. on each Sunday of each week.

SECTION 9. Any Tavern License issued, under the provisions of this Ordinance, may be revoked by the President of the Board of Trustees of the VILLAGE OF BELLEVUE upon good cause shown, as provided by the laws of the State of Illinois, in such cases made and provided.

SECTION 10. Whenever any person, firm or corporation shall be found guilty of any violation of this Ordinance, such person, firm or corporation, so found guilty, on conviction, shall be fined not less than \$25.00 nor more than \$200.00 for each such offense and each day that any such person, firm or corporation shall violate any provision of this Ordinance, as aforesaid, shall be deemed a separate offense and be punishable accordingly.

SECTION 11. A certain Ordinance, entitled "AN ORDINANCE REGULATING AND LICENSING TAVERNS IN THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS" passed and approved

by the President and Board of Trustees of the VILLAGE OF BELLEVUE the 1 day of FFB 1946, A. D. 1946, is hereby amended, in accordance with the terms and provisions of this Ordinance, and all other Ordinances pertaining to the regulation or licensing of Taverns within the VILLAGE OF BELLEVUE, now in force and effect, are repealed and superseded by this Ordinance.

SECTION 12. This Ordinance shall be effective upon its passage and publication or posting as required by law.
