AN ORDINANCE OF THE VILLAGE OF BELLEVUE,
PEORIA COUNTY, ILLINOIS, TO AMMEND "AN
ORDINANCE PROVIDING FOR THE REGULATION
AND OPERATION OF THE MUNICIPAL WATER
WORKS SYSTEM OF THE VILLAGE OF BELLEVUE,
PEORIA COUNTY, ILLINOIS, AND FIXING RATES
AND CHARGES FOR WATER AND WATER SERVICES
FURNISHED BY SAID WATER WORKS SYSTEM",
APPROVED MARCH 24, 1942,
AS NOW AMENDED

BE IT ORDAINED, by the President and Board of Trustees
of the VILLAGE OF BELLEVUE, Peoria County, Illinois, as follows:

SECTION 1: That Section 9 of "AN ORDINANCE PROVIDING
FOR THE REGULATION AND OPERATION OF THE MUNICIPAL WATER WORKS
SYSTEM OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS,
AND FIXING RATES AND CHARGES FOR WATER AND WATER SERVICES FURNISHED
BY SAID WATER WORKS SYSTEM", approved March 24, 1942, and "ORD-
INANCE TO AMEND 'AN ORDINANCE PROVIDING FOR THE REGULATION AND
OPERATION OF THE MUNICIPAL WATER WORKS SYSTEM OF THE VILLAGE OF
BELLEVUE, PEORIA COUNTY, ILLINOIS, and FIXING RATES AND CHARGES
FOR WATER AND WATER SERVICES FURNISHED BY SAID WATER WORKS SYS-
TEM'", approved July 14, 1942, and "ORDIANCNE TO AMEND 'AN ORDI-
NANCE PROVIDING FOR THE REGULATION AND OPERATION OF THE MUNICIPAL
WATER WORKS SYSTEM OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY,
ILLINOIS, AND FIXING RATES AND CHARGES FOR WATER AND WATER SERVICES
FURNISHED BY SAID WATER WORKS SYSTEM'", approved July 24, 1945, be
and the same is, hereby amended to read as follows:

"SECTION 9: All water shall be supplied through meters
and the following shall be the rates for water supplied through
said meters, payable monthly on the first day of each month:

For the first 2,000 gallons per month-		
per 1,000 gallons.....	\$1.05	1.15
For the next 3,000 gallons per month-		
per 1,000 gallons.....	.70 cents	.80

For the next 5,000 gallons per month-
per 1,000 gallons..... 50 cents

.60

For the next 5,000 gallons per month-
per 1,000 gallons..... 40 cents

.50

All over 15,000 gallons per month-
per 1,000 gallons..... 30 cents

The minimum monthly charge for service shall be \$3.00 for all domestic consumers and \$4.00 for all commercial consumers.

For water sold by the load a minimum charge of 25 cents per load of 500 gallons.

The Village shall pay a fire hydrant rental of \$1.00 per month per hydrant.

The term 'domestic consumer' shall mean and include all users of water for buildings or dwellings used exclusively for residential purposes. All other users shall be deemed to be 'commercial users.'

The Village reserves the right to make such reasonable changes in rates and in conditions herein established and to establish further rules and regulations from time to time as may be found expeditious or necessary."

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
