

ORDINANCE NO. 114
AN ORDINANCE RECREATING AND REAUTHORIZING
THE REORGANIZATION OF THE BELLEVUE WATER
BOARD IN THE VILLAGE OF BELLEVUE, PEORIA
COUNTY, ILLINOIS

SECTION I. Ordinance Number Twenty-five of the Ordinances of the Village of Bellevue, Illinois, which establishes a water commission for the Village of Bellevue, Peoria County, Illinois, is repealed in its entirety.

SECTION II. Pursuant to "An Ordinance providing for the regulation and operation of the Municipal Waterworks System of the Village of Bellevue, Illinois, Section I," there is established the Bellevue Water Board.

SECTION III. The Bellevue Water Board shall be composed of five persons. The President of the Village of Bellevue shall be a member of the Board. One Trustee of the Village of Bellevue shall be a member of the Board; he having been appointed by the Village President. The Village President shall appoint three citizens of the Village to be members of the Board.

SECTION IV. All members of the Bellevue Water Board shall be appointed for terms of four consecutive years; commencing with the first meeting of the new mayoral administration and ending with the last meeting of the mayoral administration.

SECTION V. Each member of the Bellevue Water Board shall be paid a salary of Four Dollars (\$4.00) per month. Said salary to be paid quarterly; however, each member must attend a minimum of one meeting per month to become eligible for his salary.

SECTION VI. The duties of each of the members of the Bellevue Water Board are:

- a. The Village President shall be Chairman of the Bellevue Water Board and he shall conduct the meetings of the Board. The Village President shall vote only when it becomes necessary to break a tie in the voting.
- b. One member of the Board shall be the Secretary.
- c. One member of the Board shall be the Finance Officer.
- d. One member of the Board shall be the Maintenance Supervisor.
- e. One member of the Board shall be the Purchasing Agent for the Bellevue Water Board and he shall be assisted by another member of the Board to be selected by him.
- f. Two members of the Board selected by the entire Board shall act as a Planning Committee. The Planning Committee shall suggest the policies, necessary rules and regulations of the Municipal Waterworks System; all with the approval of the Village Board of Trustees.



SECTION VII. Three persons including the Village President shall constitute a quorum for the conduct of business. A chairman and/or Secretary shall be chosen to act pro tempore if either the permanent Chairman and/or permanent Secretary are absent from the meeting. The Pro tempore Chairman shall vote only to break a tie.


SECTION VIII. The Bellevue Water Board shall make the rules and regulations necessary for the supervision and management of the Municipal Waterworks System.
