

AN ORDINANCE OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FIXING THE SALARIES OF THE OFFICERS AND TRUSTEES OF SAID VILLAGE AND PROVIDING FOR THE PAYMENT THEREOF

BE IT ORDAINED by the President and the Board of Trustees of the Village of Bellevue, Peoria County, Illinois, as follows:

SECTION 1. That from and after this date "An Ordinance of the Village of Bellevue, Peoria County, Illinois, fixing the salaries of the officers and trustees of said Village and providing for the payment thereof" passed and approved by the Board of Trustees and the President of The Village of Bellevue on April 8, 1947, is repealed in its entirety.

SECTION 2. That from and after the effective date of this Ordinance and in accordance with the laws of the State of Illinois in such cases made and provided, the annual salaries of the President of the Board of Trustees, the Clerk, the Treasurer, ~~and the Marshal~~ of the Village of Bellevue, Peoria County, Illinois, shall be and hereby fixed at the sum per year set opposite the respective titles of said officers, as follows:

President of the Board of Trustees	\$300.00
Village Clerk	\$400.00
Village Treasurer	\$200.00

SECTION 3. That one-half ( $\frac{1}{2}$ ) of the above said annual salary of the Village Treasurer shall be paid out of funds derived from the operation of the waterworks system owned by the said Village of Bellevue and that the other half ( $\frac{1}{2}$ ) of the above said salary of said Village Treasurer shall be paid out of the general corporate fund of the said Village of Bellevue.

SECTION 4. That from and after the effective date of this ordinance and in accordance with the laws of the State of Illinois in such cases made and provided, each member of the Board of Trustees of said Village of Bellevue shall be paid by the said Village the sum of FIVE and no/100 (\$5.00) DOLLARS for each regular meeting and each special meeting actually attended by such member of said Board of Trustees but that no compensation shall be paid any member of said Board of Trustees for any regular or special meeting not actually attended by such member.

SECTION 5. That all salaries and compensation provided for any officer or member of the Board of Trustees of this Village provided for in Sections 1, 2 and 3 of this Ordinance shall be paid in quarterly installments, said installments being due and payable at the end of each quarter of the fiscal year of said Village of Bellevue, as heretofore established by Ordinance.

SECTION 6. That all Ordinances and parts of Ordinances heretofore passed, approved and adopted by the said Village of Bellevue which may be in conflict with any part or provision of this Ordinance are hereby repealed.

SECTION 7. This ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
