

AN ORDINANCE LEVYING THE ANNUAL MUNICIPAL TAX AND PUBLIC BENEFIT TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1968 AND ENDING JUNE 30, 1969

BE IT ORDAINED by the President and the Board of Trustees of the Village of Bellevue, Peoria County, Illinois, as follows:

SECTION I: That the ~~sum~~ ^{sum} of Seven Thousand ~~Four~~ ^{SIX} Hundred ~~thirty-nine~~ ^{and} 50/100 (~~\$7,439.50~~) Dollars be, and the same is, hereby levied upon all the taxable property in the Village of Bellevue, Peoria County, Illinois, as a general tax for the uses of the municipal corporation of the said Village of Bellevue for the several corporate purposes for the fiscal year commencing July 1, 1968 and ending June 30, 1969, the same being the total amount of monies heretofore appropriated for the uses of said corporation for said fiscal year, less the amount estimated to be derived from sources other than taxation, the several uses and purposes for which said tax is levied and the amount levied for each of said corporate uses and purposes being as follows:

SECTION II: That the sum of Five Hundred and No/100 (\$500.00) Dollars be, and the same is, hereby levied for the fiscal year commencing July 1, 1968 and ending June 30, 1969, upon all the taxable property in said Village of Bellevue in addition to all other taxes levied in and by this ordinance and levied in and by all other ordinances, as a Public Benefit Tax, for the purpose of paying a portion of such public benefits as may have been heretofore assessed or as may be hereafter assessed against the said Village for local improvements in said Village as provided by an Act amending Section 33-2 of an Act entitled "An Act Concerning Local Improvements" approved June 14, 1897, as amended and as provided by an Ordinance of the Village of Bellevue, heretofore passed in accordance with the said Act of the General Assembly, as amended.

SECTION III: That the County Clerk of the County of Peoria in the State of Illinois is hereby authorized and directed to extend the amount of said taxes so levied by this Ordinance, to-wit:

For general corporate purposes: ~~\$7,439.50~~ 7649.50
 For Public Benefit Tax: 4500.00

Amounting in all to the sum of ~~\$7,939.50~~ \$8149.50


as a tax upon all the taxable property within the corporate limits of the said Village of Bellevue in the County of Peoria in the State of Illinois as municipal taxes for the fiscal year beginning July 1, 1968 and ending June 30, 1969.

SECTION IV: That the Village Clerk of the said Village of Bellevue, Peoria County, Illinois, is hereby directed to file a duly certified copy of this ordinance in the office of the County Clerk of the County of Peoria in the State of Illinois as required by Law.


AN ORDINANCE LEVYING THE WORKING CASH FUND TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE YEAR (FISCAL) BEGINNING JULY 1, 1968 AND ENDING JUNE 30, 1969

BE IT ORDAINED by the President and the Board of Trustees of the Village of Bellevue, Peoria County, Illinois, as follows:

SECTION I: That the sum of FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS be, and the same is, hereby levied upon all the taxable property in the said Village of Bellevue as a "Working Cash Fund Tax" for the uses of the said Village as provided by Law, for the fiscal year beginning July 1, 1968 and ending June 30, 1969, in addition to all other taxes levied in or by any and all other ordinances of the said Village for the fiscal year, in accordance with an act entitled "An Act Concerning Cities, Villages and Incorporate Towns and to Repeal Certain Acts Herein Named", approved August 15, 1941, effective January 1, 1942, as now amended, being Section 15-11 to 15-17 of Chapter 24, Illinois Revised Statutes, 1955.

SECTION II; That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.


