ORDINANCE NO. 190

AN ORDINANCE ANNEXING A PARCEL OF LAND (60 Feet BY 150 Foot) IN PART OF THE SOUTH HALF OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION TEN, TOWNSHIP EIGHT NORTH, RANGE 7 EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN PEORIA COUNTY, ILLINOIS, TO THE VILLAGE OF BELLEVUE, IN PEORIA COUNTY, ILLINOIS.

WHEREAS, the parcel of land approximately 60 feet wide and 150 feet deep lying on the northerly side of State Route No. 116, is wholly surrounded by this Village, and

WHEREAS, said parcel of land, together with the public highway or portion thereof in front of said tract or parcel, is not within any municipality, and it is of less than 60 acres, and

WHEREAS, the notice stating that annexation of the territory described in the notice is contemplated, was published in a newspaper of general circulation within the territory to be annexed, not less than 10 days before the passage of this ordinance, and

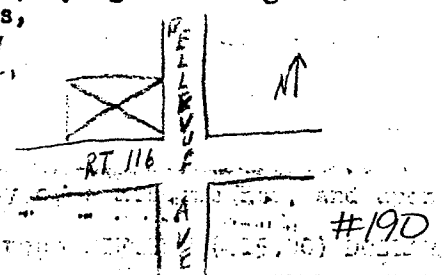
WHEREAS it is deemed to the best interest of this Village that said parcel or tract be annexed to and made a part of this Village, pursuant to the provisions of Chapter 24, Article 7-1-13, Illinois Revised Statutes, as amended.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the tract or parcel of land known and described as, to-wit:

"Part of the South half (S $\frac{1}{2}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 10, Township 8 North, Range 7 East of the 4th Principal Meridian, in Peoria County, Illinois, more particularly described as: Commencing at the intersection of the Westerly line of Bellevue Avenue in Fernwood Third Addition to Peoria County, Illinois, and the Northerly right-of-way line of State Route No. 116; thence Westerly along the Northerly right-of-way line of said Route 116, a distance of 322 feet to a pipe, the place of beginning of the tract to be described; thence North 150 feet to a stake; thence West a distance of 60 feet to a stake; thence South 150 feet, more or less, to the existing Village Boundary; thence East along the existing boundary line a distance of 60 feet; thence Northerly to the place of beginning, as shown on plat of survey prepared by The Horton Engineering Co., dated December 16, 1946, and recorded January 20, 1947, in Plat Book 697, at Page 407, in the Peoria County Recorder's Office, all situated, lying and being in the County of Peoria and State of Illinois,

be and the same is hereby annexed to and made a part of the Village of Bellevue, Peoria County, Illinois, and the same is hereby incorporated within the boundary of this Village.

SECTION 2. That the plat of survey, hereunto attached and made a part hereof, is a true, correct and accurate plat of the said parcel or tract annexed to this Village, showing its relation to the existing boundary lines of this Village.

SECTION 3. That the Village Clerk shall forthwith prepare and record an exact copy, certified, of this Ordinance, together with an exact copy of the plat hereunto attached, in the office of the Recorder of Deeds of Peoria County, Illinois, upon the taking effect of this Ordinance.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
