ORDINANCE NO. 191

ANNUAL APPROPRIATION ORDINANCE FOR THE VILLAGE OF BELLEVUE
PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING
JULY 1, 1969 AND ENDING JUNE 30, 1970.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
