

AN ORDINANCE ANNEXING PART OF THE SOUTHEAST QUARTER OF SECTION THREE AND PART OF THE NORTHEAST QUARTER OF SECTION TEN, ALDIN RANGE 7, EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN PEORIA COUNTY, ILLINOIS, TO THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS.

WHEREAS, there has been duly filed with the Village Clerk of the VILLAGE OF BELLEVUE, Peoria County, Illinois, a verified Petition for the annexation of a parcel of land contiguous with the existing boundary of the Village of Bellevue, and

WHEREAS, said Petitioners on oath state that they are the sole owners of record of all of the land sought by them to be annexed to this Village and that there are no electors residing thereon, and

WHEREAS, said described territory is not within the corporate limits of any other municipality, and

WHEREAS, this Village Board has found the allegations of the Petition to be correct and the plat attached to correctly and accurately show the location of said parcel and the existing boundary line of this Village, and

WHEREAS, it now becomes the duty of this Village Board to consider the question of the annexation, and

WHEREAS, it is found that such annexation of the territory sought to be annexed under the provisions of Chapter 24, Article 7-1-8, Illinois Revised Statutes, 1967 Edition, as amended, is to the best interest of this Village and the request of the Petitioners should be granted.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the parcel or tract of land known and described as, to-wit:

Part of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Three (3), Township Eight (8) North, Range Seven (7) East of the Fourth Principal Meridian, more particularly described as follows, to-wit: Commencing at the Southwest corner of said Quarter Section, thence North upon the West line of said Quarter Section, 524.6 feet, more or less, to the Southerly line of the Farmington Road (State Bond Issue Route No. 8); thence East upon said Southerly line of said Farmington Road (Route 8), a distance of 40.0 feet; thence South, parallel with said West line of said Quarter Section, 525 feet, more or less, to the South line of said Quarter Section; thence West upon said South line of said Quarter Section, 40 feet to the place of beginning;

Site of Deluxe Mobile Homes

AND ALSO, a tract of land in the Northwest corner of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Ten (10), Township Eight (8) North, Range Seven (7) East of the Fourth Principal Meridian, more particularly bounded and described as follows, to-wit: Commencing at a point 660.0 feet North of the center of said Section Ten (10); running thence North 1983.1 feet, more or less, along the Westerly line of said Northeast Quarter (NE $\frac{1}{4}$ ) to the Northerly line of said Northeast Quarter (NE $\frac{1}{4}$ ); running thence East, 853.5 feet, more or less; thence South 1984.6 feet, more or less; thence West 867 feet, more or less, to the place of beginning, containing approximately 39.17 acres,

all situated, lying and being in the County of Peoria and State of Illinois,

be and the same is hereby annexed to and made a part of the Village of Bellevue, Peoria County, Illinois, and the same is hereby incorporated within the boundaries of this Village.

SECTION 2. That the plat hereunto attached and expressly made a part hereof, is a true, correct and accurate plat or map of the territory annexed to this Village and correctly shows the relation of existing monuments with the parcel hereby annexed.

SECTION 3. That the Village Clerk shall, file in the Office of the Recorder of Peoria County, Illinois, a copy of this ordinance, together with a plat of said territory annexed.

SECTION 4. That the zoning of said parcel or tract shall be and the same is hereby zoned for use as a mobile home park and/or subdivision pursuant to agreement with the parties at interest and such classification shall remain subject to such zoning and use.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage and due publication as provided by law.

PASSED by the Village Board of the Village of Bellevue, Peoria County, Illinois, by majority vote of the corporate authorities holding office in this Village, at a regular public meeting assembled this 12 day of August, A. D. 1969.
