

ORDINANCE NO. 201

AN ORDINANCE MAKING THE BUDGET AND APPROPRIATIONS FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE CURRENT FISCAL YEAR BEGINNING JULY 1, 1970, AND ENDING JUNE 30, 1971, to be known as the 1970 Annual Budget and Appropriate Ordinance.

WHEREAS, it is incumbent upon the President and Board of Trustees of the Village of Bellevue, Peoria County, Illinois, to prepare an Annual Budget and Appropriate ordinance of the anticipated necessary corporate expenses for the current fiscal year; and

WHEREAS, the said Officers have prepared the amounts deemed necessary to meet the necessary corporate expenses for the fiscal year beginning July 1, 1970, and ending June 30, 1971, as hereinafter set forth:

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 2. That said sum or sums so budgeted and appropriated or so much there of as may be lawful for said corporate purposes is hereby budgeted and appropriated for the various accounts as shown;

SECTION 3. That if the amounts appropriated, said sum or sums may be used to make up any deficiency in any other fund or funds of any like or

or general classification.

SECTION 4. This Ordinance shall be in full force and effect from and after its publication as provided for by law.

SECTION 5. All ordinances or parts of ordinances in conflict herewith are as to such conflict, hereby repealed.


