

ORDINANCE NO. 202

AN ORDINANCE LEVYING AND ASSESSING THE MUNICIPAL TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1970, AND ENDING JUNE 30, 1971, TO BE KNOWN AS THE ANNUAL TAX LEVY FOR THE YEAR 1970.

Whereas, the President and Trustees of the Village of Bellevue, Peoria County, Illinois, have duly passed and adopted the Annual Budget and Appropriation Ordinance for the current fiscal year, and

Whereas, more than ten days have elapsed since the publication of said Annual Budget and Appropriation Ordinance and this Board now has the duty of passing the Annual Tax Levy for the current fiscal year.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That there is levied and assessed upon all of the taxable property within the corporate limits of the Village of BELLEVUE, Peoria County, Illinois, for the current fiscal year beginning July 1, 1970, and ending June 30, 1971, the total sum of TWENTY-THREE THOUSAND FIVE HUNDRED NINETY-FOUR and no/100 (\$23,594.00) DOLLARS, said sum being the total of all funds for which Levy is made, as required to meet the necessary corporate purposes of this Village, as more specifically shown:



That the County Clerk is hereby authorized and directed to levy upon all taxable property in the Village of Bellevue, Peoria County, Illinois, that is the subject of taxation, the sum of \$23,594.00, for the purposes of defraying all of the necessary corporate expenses of this Village, according to law, for the fiscal year 1970 and 1971, as set forth during this fiscal year, to be received in 1971.


