ORDINANCE NUMBER 204

AN ORDINANCE OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS

BE IT ORDAINED, by the President and the Board of Trustees of the Village of Bellevue, Peoria County, Illinois:

SECTION I. Pursuant to the provisions of Chapter 27, Section 7-1-8, Illinois Revised Statutes, 1965, the following-described real property is hereby annexed to the Village of Bellevue, Illinois, in the County of Peoria and State of Illinois:

The Northeast Quarter of Section Eleven (11), EXCEPTING however, the West Half of the Southwest Quarter of the Northeast Quarter of said Section Eleven (11);

ALSO the East Half of the East Half of the Northwest Quarter of Section Eleven (11);

ALSO all that part of the East Half of the East Half of the Southwest Quarter of Section Eleven (11) as lies North of the Peoria and Farmington Plank Road as the same existed on August 24, 1855; EXCEPTING all coal and mineral rights, and

ALSO EXCEPTING part of the Northeast Quarter of Section Eleven (11), more particularly bounded and described as follows, to-wit: Beginning on the North Quarter Section line, Eleven Hundred Seventy (1,170) feet West of the Northeast corner of said Section Eleven (11) at a point where the West line of Lot Seventy-seven (77) in Crestview Subdivision intersects the North line of said Quarter Section; thence West Four Hundred (400) feet; thence South One Hundred Thirty-two (132) feet; thence East Four Hundred (400) feet; thence North One Hundred Thirty-two (132) feet to the point of beginning;

ALSO EXCEPTING, part of the Northeast Quarter of the Southwest Quarter of said Section Eleven (11), more particularly bounded and described as follows, to-wit: Beginning at a point on the East line of the Southwest Quarter of Section Eleven (11), One Hundred Twelve and Eighty-six hundredths (112.86) feet South of the Northeast corner thereof; thence West Two Hundred Seventy-four and Fifty-six hundredths (274.56) feet; thence South Three Hundred Seventeen and Forty-six hundredths (317.46) feet; thence East Two Hundred Seventy-four and Fifty-six hundredths (274.56) feet; thence North Three Hundred Seventeen and Forty-six hundredths (317.46) feet to the place of beginning; all in Township Eight (8) North, Range Seven (7) East of the Fourth Principal Meridian; situate, lying and being in the County of Peoria and State of Illinois
