

ORDINANCE NO. 213

AN ORDINANCE LEVYING AND ASSESSING THE MUNICIPAL TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1971 AND ENDING JUNE 30, 1972.

WHEREAS, the President and Board of Trustees of this Village have duly adopted its Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 1971, and ending June 30, 1972, and

WHEREAS, the corporate authorities have determined the levy required to be made, making no levy for Election expenses amounting to \$300.00, no levy for Motor Fuel Tax, amounting to \$5250.00, and no levy for the Water Department, amounting to \$45,300.00, thereby deducting from the Appropriation the total sum of \$50,850.00, as such reductions are funds to be derived from other sources, thereby leaving a balance to be raised by this levy in the sum of FORTY-THREE THOUSAND FIFTY and no/100 DOLLARS, (\$43,050.00).

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That there is hereby levied and assessed upon all of the taxable property within the corporate limits of the VILLAGE OF BELLEVUE, Peoria County, Illinois, the same being the amount deemed necessary to be raised by taxation upon all real and personal property that is subject to taxation according to the valuation thereof as equalized by the laws pertaining thereto, the sum of \$43,050.00, which said amount is the total of all General and Special Funds more specifically set forth as follows:

may be lawful and as is authorized by law to meet the necessary corporate expenses of this municipality.


SECTION 4. This Ordinance shall be in full force and effect from and after its passage, as is provided for by law.


VILLAGE CLERK'S CERTIFICATE
