AN ORDINANCE EXPRESSING THE DESIRE OF THE CORPORATE AUTHORITIES
OF BELLEVUE, ILLINOIS TO ANNEX TO THE VILLAGE OF BELLEVUE,
ILLINOIS CERTAIN UNINCORPORATED TERRITORY LOCATED IN SECTION 14,
TOWNSHIP 8 NORTH, RANGE 7 EAST OF THE FOURTH PRINCIPAL MERIDIAN,
IN PEORIA COUNTY, ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

Section 1. That it is the desire of the corporate
authorities of the Village of Bellevue, Illinois, to annex to
the Village of Bellevue, Illinois, the unincorporated territory
hereinafter described in Section 3 hereof.

Section 2. That said territory hereinafter described
in Section 3 hereof, is contiguous to the Village of Bellevue,
Illinois; is not within the corporate limits of any municipality;
and includes no tract of land in excess of ten acres in area
without the express consent of the owner thereof.

Section 3. The Village Board of Trustees of the Village
of Bellevue, Illinois requests the annexation to the Village of
Bellevue, Illinois, of the territory described as follows:

All that part of the West Half ($W\frac{1}{2}$) of the Northwest
Quarter ($NW\frac{1}{4}$) of Section Fourteen (14), Township
Eight (8) North, Range Seven (7) East of the Fourth
Principal Meridian, lying South of the northerly
right-of-way line of the Chicago and North Western
Railway Company, Peoria County, Illinois.

Section 4. The Village Board of Trustees of the Village of Bellevue, Illinois, directs the Corporation Counsel of the Village of Bellevue, Illinois, to file a certified copy of this Ordinance with the Circuit Clerk of the Tenth Judicial Circuit, Peoria County, and requests the Court, upon the filing of said copy of this Ordinance, to enter an Order fixing the time of hearing upon this Ordinance, and upon said hearing to find that this ordinance is valid, and to direct that there be submitted to the electors residing within the unincorporated territory hereinabove described in Section 3 hereof, the question of whether said territory shall be annexed to the Village of Bellevue, Illinois, at a special election on a date to be fixed by the Court, all as provided in Sections 7-1-2, 7-1-4 and 7-1-7, Chapter 24, Illinois Revised Statutes, said Chapter 24 being known as the "Illinois Municipal Code."

Section 5. This Ordinance shall be in full force and effect from and after its passage and approval according to law.
