

ORDINANCE NO. 221

AN ORDINANCE MAKING ANNUAL APPROPRIATION FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING JULY 1, 1972, AND ENDING JUNE 30, 1973.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. THAT THE FOLLOWING SUM OR SUMS OF MONEY, OR SO MUCH THEREOF AS MAY BE AUTHORIZED BY LAW, AND AS MAY BE NEEDED AND ARE DEEMED NECESSARY TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES, OF THIS VILLAGE, BE AND THE SAME ARE HEREBY APPROPRIATED FOR THE NECESSARY CORPORATE PURPOSES AND OBJECTS OF THIS VILLAGE FOR THE FISCAL YEAR BEGINNING JULY 1, 1972 AND ENDING JUNE 30, 1973, THAT IS TO SAY:
