

ORDINANCE NO. 228

AN ORDINANCE MAKING THE ANNUAL APPROPRIATION FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING JULY 1, 1973 AND ENDING JUNE 30, 1974.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1.
