ORDINANCE NO. 229

AN ORDINANCE ANNEXING A PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 11, TOWNSHIP 8 NORTH, RANGE 7 EAST OF THE 4th PRINCIPAL MERIDIAN, AND PART OF THE WEST HALF OF THE EAST HALF OF SAID SECTION 11, ALL BEING IN LIMESTONE STOWNSHIP, PEORIA COUNTY, ILLINOIS, TO THE VILLAGE OF BELLEVUE, ILLINOIS.

WHEREAS, this Village Board adopted a Resolution upon July 10, 1973, indicating that consideration was being made to adopt a tract or territory containing less than 60 acres, completely surrounded by this Village, and

WHEREAS, said Notice of intention to annex said territory was published in The Peoria Journal Star, a newspaper of general circulation regularly circulated throughout the territory sought to be annexed, more than ten days prior to any consideration thereon, and

WHEREAS, the annexation action is taken pursuant to Section 7-1-13, of Chapter 24 (The Municipal Code), being Illinois Revised Statutes of 1971, and

WHEREAS, this Board of Trustees having determined to annex said territory as being in the best interests of this Village.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the tract or parcel of land, known and described as, to-wit:

The West Half of the Southwest Quarter of the Northeast Quarter of Section 11, Township 8 North, Range 7 East of the 4th Principal Meridian,

ALSO,

All that part of the Northwest Quarter of the Southeast Quarter of said Section 11 lying Northeasterly of the center-line of Plank Road (Rte. 116), excepting therefrom Part of the Southeast Quarter of said Section 11, more particularly bounded and described as follows:

Commencing at a point on the North line of said Southeast Quarter, 1,416.6 feet West of the Northeast corner of said Quarter; thence South 1,570.8 feet to the center-line of Plank Road (now known as Rte. 116); thence Northerly along the center of said road 396.0 feet; thence North 1,335.84 feet to the north line of said Southeast Quarter of Section 11; thence East along said north line of said Southeast Quarter 310.2 feet to the place of beginning as recorded on Plat No. 229

East 274.56 feet; thence North 317.46 feet to the place of beginning,

all being situated in Limestone Township, in the County of Peoria and State of Illinois, containing 42.0 acres, more or less,

be and the same is hereby annexed to and made a part of the Village of Bellevue, Peoria County, Illinois, and incorporated within the boundaries of this Village.

SECTION 2. That the Plat hereunto attached, showing the territory hereby annexed and its relation to the existing boundaries of this Village, is a true, correct and accurate plat and correctly shows the area and monuments it was intended to show and portray.

SECTION 3. That proof of notification by the Village Clerk of this annexation having been given to the Fire District and to the Library District, having been filed, indicating that such notice was given more than ten days prior to any final action hereon.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage and due publication as provided for by law.

Passed by the Board of Trustees of the Village of Bellevue, Peoria County, Illinois, in regular public session assembled this 14 day of August, A. D. 1973.
