

ORDINANCE NO. **241**

AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1974 AND ENDING JUNE 30, 1975.

WHEREAS, there has been appropriated such sum or sums of money deemed necessary for the necessary corporate purposes of this Village, which said appropriation was made in the first quarter of this fiscal year, and was duly published in Peoria Journal Star upon August 16, 1974, more than ten days prior to any action taken on this Levy, and

WHEREAS, it is now the duty of of the Village Board to determine the necessary expenses for the operation of this Village and to Levy a Tax for such purposes.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the following sum or sums of money, or so much thereof as may be authorized by law, are deemed necessary to defray the necessary corporate expenses and obligations of this Village of Bellevue, and the same are hereby levied and assessed against all of the properties in this Village that is subject to taxation according to law, in order to raise the sum of FIFTY-FIVE THOUSAND EIGHT HUNDRED FIFTEEN DOLLARS (\$55,815.00), total of both General Funds and Special Tax funds, for the purposes as follows:






