

ORDINANCE NO. 253

AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1977 AND ENDING JUNE 30, 1978.

WHEREAS, the Annual Budget and Appropriation Ordinance was duly passed and adopted upon August 9, 1977, making appropriations of funds necessary for the corporate purposes of this Village, and now more than ten days having passed since such passage and the publication of said ordinance by authority of the Village Board to be published in pamphlet form upon said August 9, 1977, and

WHEREAS, it is now the duty of this Village Board to determine the amount necessary to be levied for the corporate purposes of this Village.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the following sum or sums, or so much thereof as may be authorized by law, are deemed necessary to meet the necessary corporate purposes and expenses of this Village, and the same are hereby levied against all properties that are subject to taxation in this municipality in order to raise the sums necessary for the General Fund, the Special Funds and various funds levied as follows:
