

ORDINANCE NO. **261**

AN ORDINANCE MAKING THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1979 AND ENDING JUNE 30, 1980.

WHEREAS, it is incumbent upon the Board of Trustees to make the Annual Budget and Appropriation Ordinance for the Village of Bellevue, in the first quarter of the fiscal year, which is fixed as beginning July 1, 1979, and ending JUNE 30, 1980, and

WHEREAS, the Village Board have determined the various amounts to be budgeted and appropriated for the necessary corporate purposes of this Village during said Fiscal Year, and

WHEREAS, whereas the Annual Budget and Appropriation Ordinance has been made conveniently available for public inspection in tentative form for more than ten days prior to any action taken on the adoption thereof and a public hearing was held after due notice given according to law.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That there is hereby appropriated the several sums as may be authorized by law, to meet the necessary corporate purposes of the Village of Bellevue, Peoria County, Illinois, as follows:

A special Tax of .076% to provide additional Revenue for the purpose of Police Protection, as authorized by Chapter 24, Para. 11-1-3, Ill. Rev. Statutes, and provided for in Village Ordinance No. 251. - - - - - \$2,800.00

REVENUE SHARING FUND:

School Crossing Guards - - - - - \$1,000.00

SECTION 2. That the various amounts appropriated may be used to make-up any deficiency in any other like appropriation.

SECTION 3. This ordinance shall be published in pamphlet form as provided for by law, and as so published on the date of adoption, the same shall be in full force and effect from and after its passage and such publication as provided for by law.

SECTION 4. All ordinance or parts of ordinances in conflict herewith are, as to such conflict, hereby repealed.
