AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 1980 AND ENDING JUNE 30, 1981.

WHEREAS, the Annual Budget and Appropriation Ordinance was duly passed and adopted upon August 12, 1980, fter public hearing duly held and notices posted, and not more than 10 days having passed since the adoption of said Annual Budget and Appropriation Ordinance, it is now the duty of the President and Board of Trustees to adopt the Annual Tax Levy for said Village to meet the necessary corporate purposes thereof.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the following sum or sums, or so much thereof as my be authorized by law, be and the same are hereby levied against all properties that are subject to taxation within the Village of Bellevue, in order to raise the amounts levied for the General Fund, the Special Funds and the various funds hereby levied, as follows:
