VILLAGE OF BELLEVUE, ILLINOIS
ORDINANCE ADOPTING BUILDING CODE

WHEREAS, the Board of Trustees of the Village of Bellevue has determined that the best interests of the Village and its residents will be served by the adoption of regulations governing the construction of buildings within the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the BOCA National Building Code, Eleventh Edition, 1990 (the "Code"), as published by the Building Officials and Code Administrators International, Inc., be and hereby is adopted as the Building Code of the Village of Bellevue, Illinois, for the control of buildings and structures, as hereinafter provided; and all of the regulations, provisions, penalties, conditions and terms of the Code are hereby made a part hereof as if fully set forth in this Ordinance, as amended in Section 3 hereof.

SECTION 2: All other ordinances in conflict herewith, in whole or in part, are repealed to the extent of said conflict. Notwithstanding the foregoing, any ordinance of the Village imposing stricter or more specific standards than those set forth herein shall remain in full force and effect.

SECTION 3: The Code is hereby amended as follows:

- Section 100.1: "Village of Bellevue" is hereby added as appropriate.

- Section 103.4: "September 10, 1990" is hereby added as appropriate.
- Section 114.3.1: "A fee schedule is attached hereto" shall be added to the end of said section.
- Section 117.4: "ordinance violation, punishable by a fine of not more than two hundred dollars (\$200) or imprisonment not exceeding thirty (30) days, or both" is hereby added as appropriate.
- Section 118.2: "not less than twenty-five dollars (\$25) nor more than two hundred dollars (\$200)" shall be added as appropriate.
- Section 123.3: "the hourly rate paid by the Village to the Village Engineer" shall be added as appropriate.
- Section 2906.1: "One Hundred Thousand Dollars" shall be added in three appropriate places.

SECTION 4: This Ordinance shall become effective upon adoption by the Board of Trustees.
