AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN TERRITORY TO THE VILLAGE OF BELLEVUE, ILLINOIS

WHEREAS, the tract of land described on Exhibit A attached hereto and made a part hereof is contiguous to the Village of Bellevue, is wholly bounded by the Village, is not within the corporate limits of any municipality and is less than 60 acres; and

WHEREAS, pursuant to Section 7-1-13 of the Illinois Municipal Code (Ill.Rev.Stat. 1991, ch. 24, §7-1-13), surrounded territory may be annexed by the municipality which surrounds the territory; and

WHEREAS, the Village Board of Trustees has determined that it is necessary, advisable and in the public interest that the tract of land described on Exhibit A be annexed to the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bellevue, in the County of Peoria and State of Illinois:

That the tract of land described on the Section 1: attached Exhibit A be and the same is hereby annexed to and made a part of the Village of Bellevue, in the County of Peoria and the State of Illinois.

Section 2: That the Village Clerk shall file for record in the office of the Recorder of Deeds of Peoria County, Illinois and in the office of the Clerk of Peoria County, Illinois a certified copy of this Ordinance along with a map of the above-described tract of land.

<u>Section 3</u>: This Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.
