

VILLAGE OF BELLEVUE, ILLINOIS

AN ORDINANCE PROVIDING FOR ANNEXATION OF
CERTAIN TERRITORY TO THE VILLAGE OF BELLEVUE, ILLINOIS

WHEREAS, petitions signed and verified by EDITH CLOAT, surviving joint tenant of FRED CLOAT, RAYMOND E. DUTLINGER, BARBARA DUTLINGER, JOHN STRUBE, PATRICIA M. STRUBE, RONALD CLOAT and MARY CLOAT ("Owners") have been filed with the Village Clerk pursuant to and in conformance with Chapter 65, Sections 5/7-1-8 of the Illinois Revised Statutes, requesting annexation to this Village of the tracts of land substantially described therein; and

WHEREAS, it appears that the above named persons constitute the owners of record of the tracts of land, and that no electors (other than the owners) reside in said tracts; that said tracts of land are not within the corporate limits of any municipality; and that they are contiguous to the present corporate limits of the Village of Bellevue;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That the tracts of land described on the attached Exhibit A are hereby annexed to and made a part of the Village of Bellevue, in the County of Peoria and the State of Illinois.

Section 2: That the Village Clerk shall file for record in the office of the Recorder of Deeds of Peoria County, Illinois and in the office of the Clerk of Peoria County, Illinois a certified copy of this Ordinance along with a map of the above-described tracts of land, a copy of which is attached hereto as Exhibit B.

Section 3: This Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.

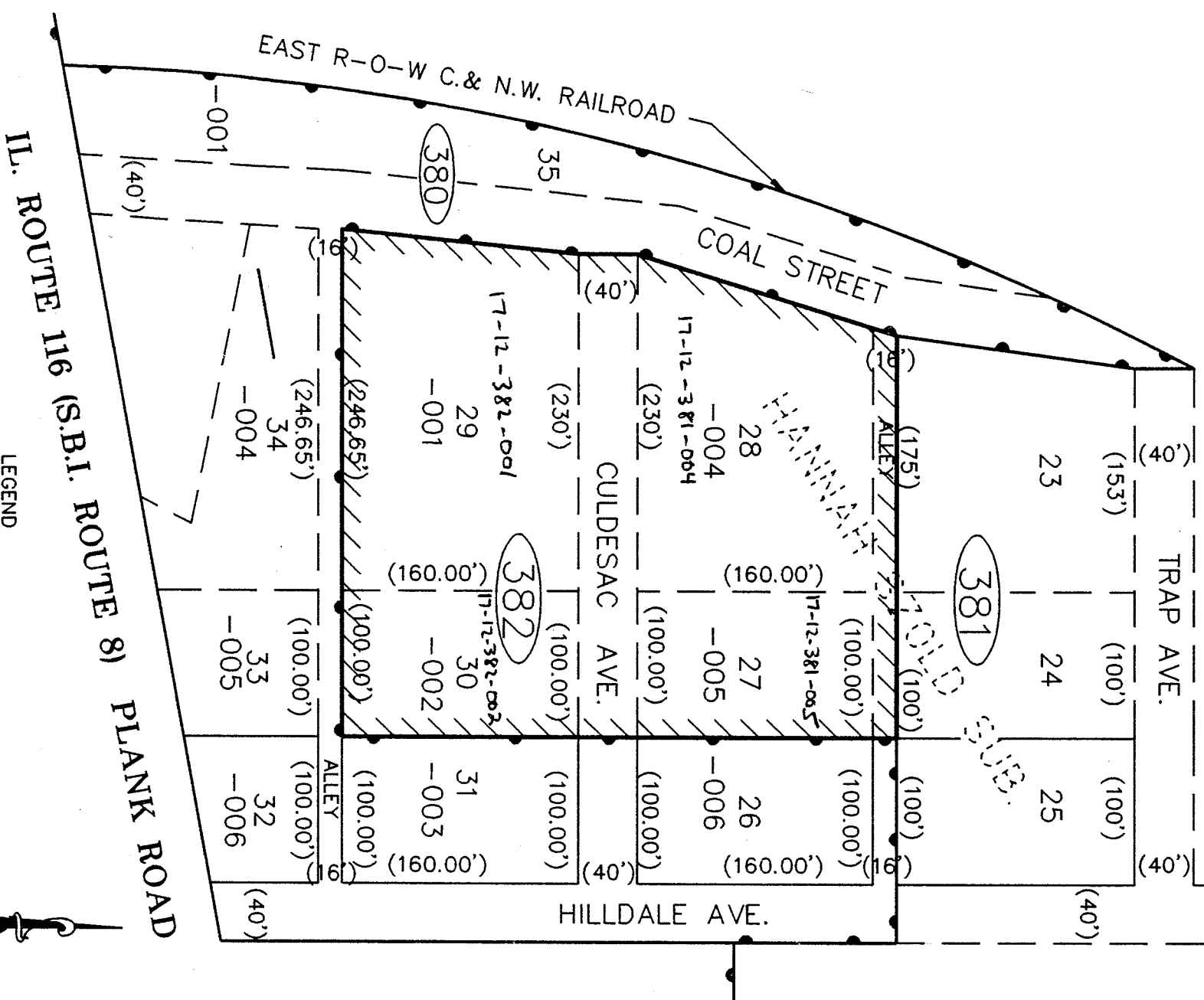

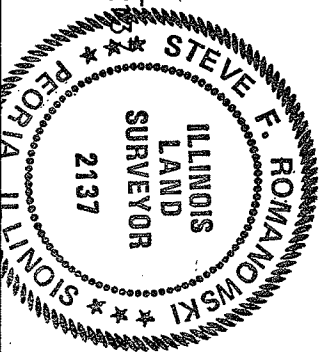
