

ORDINANCE NO. 605

VILLAGE OF BELLEVUE, ILLINOIS
ORDINANCE APPROVING SALE OF REAL ESTATE AND ACCEPTING BID

WHEREAS, the Village of Bellevue Board of Trustees ("Board") previously adopted Ordinance Number 604 wherein the Board authorized the Village President to sell the following described real property commonly known as 5726 W. Plank Road, Bellevue, Illinois by public bid:

Lot 1 in KENRICK'S ADDITION to Bellevue Acres, being a subdivision of part of the Southeast Quarter of Section 10, Township 8 North, Range 7 East of the Fourth Principal Meridian, situated in Peoria County, Illinois

(hereinafter referred to as "Lot").

WHEREAS the President subsequently published a public notice that the Village would accept bids on the Lot on or before the August 27, 2007 Board meeting; and,

WHEREAS Harry C. Murphy and Erik L. Bruce doing business as Machine Medics were the high bidder with a total bid of \$30,00.00 for the Lot.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

The Village hereby accepts the bid of Harry C. Murphy and Erik L. Bruce doing business as Machine Medics of \$30,000.00 for the Lot and the President is hereby authorized to execute all documents necessary to convey said lot per the aforesaid bid.

This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.


