ORDINANCE NO. 609

VILLAGE OF BELLEVUE, ILLINOIS

AN ORDINANCE TO AMEND ORDINANCE NO. 553
REGULATING THE USE AND ZONING OF PROPERTIES WITHIN
THE VILLAGE OF BELLEVUE, ILLINOIS

WHEREAS, the Village of Bellevue has petitioned for and, at a meeting held pursuant to notice as provided by law, received the recommendation of the Village Zoning Commission for rezoning the property described below from its present zoning status to the C-1 Neighborhood Commercial classification.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: Ordinance No. 553 of the Village of Bellevue, and any and all amendments and exhibits thereto, shall be amended so as to classify the subject property, legally described as:

THE WEST 140.67 FEET OF LOT 31, BLOCK "B" IN BELLEVUE ACRES, A SUBDIVISION OF PART OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHP 8 NORTH, RANGE 7 EAST OF THE 4TH PRINCIPAL MERIDIAN, EXCEPTING HOWEVER, ALL THE COAL AND MINERAL RIGHTS UNDERLYING THE PREMISES AFORESAID

PART OF PIN: 17-10-428-039

to the C-1 Neighborhood Commercial classification.

Section 2: This Ordinance shall take effect and be in full force from and after its passage and publication as provided by law.
