

ORDINANCE NO. 1048

VILLAGE OF BELLEVUE, ILLINOIS

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN TERRITORY
TO THE VILLAGE OF BELLEVUE, ILLINOIS

WHEREAS, the tract of land described on **Exhibit A** attached hereto and made a part hereof is contiguous to the Village of Bellevue, wholly bounded by the Village, not within the corporate limits of any municipality and less than 60 acres;

WHEREAS, pursuant to §7-1-13 of the Illinois Municipal Code (65 ILCS 5/7-1-13), unincorporated territory surrounded by the limits of a municipality may be annexed by the surrounding municipality; and

WHEREAS, the Village Board of Trustees has determined that it is necessary, advisable and in the public interest to annex to the Village of the tract of land described in **Exhibit A**.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, THE FOLLOWING:

Section 1: The tract of land described on the attached **Exhibit A** is hereby annexed to and made part of the Village of Bellevue, Peoria County, Illinois.


Section 2: The Village Clerk shall file, or cause to be filed, for record in the office of the Recorder of Deeds of Peoria County, Illinois and in the office of the Clerk of Peoria County, Illinois a certified copy of this Ordinance along with a map of the above-described land.

Section 3: This Ordinance shall be in full force and effect from and after the date of passage, approval and recordation as provided by law.
