**ORDINANCE NO. 666**

**VILLAGE OF BELLEVUE, ILLINOIS**

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF  
TAXES FOR THE FISCAL YEAR  
BEGINNING JULY 1, 2012 AND ENDING JUNE 30, 2013**

**WHEREAS**, on November 26, 2012, the Village of Bellevue Board of Trustees adopted the Annual Appropriation Ordinance for the Village's fiscal year beginning July 1, 2012 and ending June 30, 2013; and

**WHEREAS**, the Annual Appropriation Ordinance appropriated a total of **\$1,022,300** for the fiscal year; and

**WHEREAS**, of the total appropriations, the sum of \$996,100 need not be included in the tax levy;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:**

**SECTION 1:** That the sum of \$26,200, being that portion of the total appropriation heretofore legally made which is needed from the tax levy for the current fiscal year of the Village of Bellevue, Illinois, be and the same is hereby levied upon all of the taxable property in the Village of Bellevue, Illinois, which is subject to taxation in the current fiscal year. The total amount levied under each of the various taxes levied is as follows:

A.	General Corporate Tax	\$14,850


