AN ORDINANCE, LEVYING THE ANNUAL MUNI-CIPAL TAX, PUBLIC BENEFIT TAX AND WORK-ING CASH FUND TAX FOR THE VILLAGE OF BELLEVUE, IN THE COUNTY OF PEORIA, IN THE STATE OF ILLINOIS, FOR THE FISCAL YEAR, BEGINNING JULY 1, 1946, and ENDING JUNE 30, 1947.

BE IT ORDAINED, by the President and Board of Trustees of the VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, as follows:

Eighty-seven and no/100 Dollars (\$2,887.00) be, and the same is, hereby levied upon all the taxable property in the VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, as a general tax for the uses of the Municipal Corporation of the said VILLAGE OF BELLEVUE for the several corporate purposes for the fiscal year, commencing July 1, 1946 and ending June 30, 1947, the same being the total amount of monies heretofore appropriated for the uses of said corporation for said fiscal year, less the amount estimated to be derived from sources other than taxation, the several uses and purposes for which said taxas levied and the amount levied for each of said corporate uses and purposes being as follows:

SECTION II: That the sum of Three Hundred and 00/100 (\$300.00) Dollars be, and the same is, hereby levied for the fiscal year commencing July 1, 1946 and ending June 30, 1947, upon all the taxable property in the said VILLAGE OF BELLEVUE in addition to all other taxes levied in and by this Ordinance and all other Ordinances, as a Public Benefit Tax, for the purpose of paying a portion of such Public Benefits as may have been heretofore assessed or as may be hereafter assessed against the said Village for Local Improvements in said Village, as provided by an Act amending Section 33-B or an Act entitled "AN ACT CONCERNING LOCAL IMPROVEMENTS", approved June 14, 1897, as amended and as provided by an Ordinance of the said VILLAGE OF BELLEVUE heretofore duly passed in accordance with the said Act of the General Assembly as amended.

SECTION III: That the sum of Three Hundred and 00/100 (\$300.00) Dollars be, and the same is, hereby levied upon all the taxable property in the said VILLAGE OF BELLEVUE as a "Working Cash Fund Tax" for the uses of the said VILLAGE OF BELLEVUE, provided by

law, for the fiscal year beginning July 1, 1946 and ending June 30; 1947, in addition to all other taxes levied in and by this Ordinance or any other Ordinance of the said Village for the said fiscal year, in accordance with an Act entitled "AN ACT CONCERNING CITTES, VILLAGES AND INCORPORATED TOWNS AND TO REPEAL CERTAIN ACTS HEREIN NAMED", approved August 15, 1941, effective January 1, 1942, being Sections 15 - 11 to 15 - 17, both inclusive, of Chapter 24, 1943 Illinois Revised Statutes.

SECTION IV: That the County Clerk of the County of Peoria, in the State of Illinois, is hereby authorized and directed to extend the amount of said taxes so levied by this Ordinance, to-wit:

as a tax upon all the taxable property within the Corporate Limits of the said VILLAGE OF BELLEVUE, in the County of Peoria, in the State of Illinois, as municipal taxes for the fiscal year beginning July 1, 1946 and ending June 30, 1947.

SECTION V: That the Village Clerk of the said VILLAGE OF BELLEVUE is hereby directed to file a duly certified copy of this Ordinance in the Office of the County Clerk of the County of Peoria, in the State of Illinois, as required by law.

SECTION VI: That this Ordinance shall be in full force and effect from and after its passage and approval, as required by law.
