AN ORDINANCE DEFINING THE DUTIES OF THE VILLAGE OF BELLEVUE,

PEORIA COUNTY, ILLINOTO

BE IT ORDAINED by the President and the Board of Trustees of the Village of Bellevue, Peoria County, Illinois

SECTION 1 ML

Peoria County, Illinois shall be the custodian of all the funds of the said Village of Bellevue whether derived from taxation, energtion of a waterworks system or other utility system owned We surer shall deposit all such funds of the Village of Bellevue comby the Village of Bellevue or otherwise; that said Village Treas-Lowling into the hands of said Treasurer in depositaries duly authoraccounts of said Village in said depositaries such funds as may lized by said Village; that said Treasurer shall disburse from the be duly authorized to be disbursed by said Village by check signed by the President of said Village, by the Clark of said Village and by the Treasurer of said Village; that said Village Treasurer shall deposit all revenue collected by him from the operation of the said waterworks system owned by the Villege of Bellevus between the first day and the tenth day of each calendar month, both inclusive, not later than the fifteenth day of such calendar month and shell deposit in said depositary all revenue collected by said Village Treas urer from the operation of said waterworks system between the eleventh day and the last day of each calendar month, both inclusive, not later than the fifth day of the calendar month following the month in which the same may be collected; that in addition to accounts which may be otherwise provided by law said Village Treasurer shall prepare and submit to the President and the Board of

Trustees of the said Village of Eallevue at the first regular meeting following the end of each quarter of the fiscal year of soid Village of Bellevue a full, complete and accurate financial report showing the balance of funds on hand in each and every account of said Village at the beginning of the cuerter for which the report is made, showing all receipts and disbursements during the quarter for which the report is made and showing the balances on hand in each of the funds of sold Village at the end of the quarter for which said report is made and further showing all other matters of every kind whatsoever within the knowledge of said Treasurer affecting the funds, accounts, finances or financial stending of 灣 the said Village of Bellevue; that said Village Tressurer shall, within the time stated, furnish a copy of said financial report to the weter commission of said Village and an additional copy of said Cinancial report to the Board of Trustees of said Village; that said Village Treasurer shall prepare, sign and deliver orders or checks drawn on waterworks furds of said Village in manner and time as ordered by the water commission of seid Village; thet said Village Treasurer shall prepare, sign and deliver checks or orders for the payment of money on funds of said Village other than funds of said waterworks in manner and time as authorized and directed by the Board of Trusters of said Village; that said Village Treasurer shall promptly do and perform all duties herein provided and such other acts and dutles as may be necessary to collect funds belonging to said Village, to reduce the same to A and control for the benefit of said Village, to keep and safeguard said funds for the benefit of said Village and to disburse said funds in accordance with the Ordinance: of said Village and such other law as may be in such asses made and provided.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage and approval, as required by law.
