## ordinance no. 193

AN ORDINANCE PROVIDING FOR A MUNICIPAL SERVICE OCCUPATION TAX IN THE VILLAGE OF BELLEVUE, IN THE COUNTY OF PEORLA AND STATE OF ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTRES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. A tax is hereby imposed upon all persons engaged in this municipality in the business of making salus of services at the rate of one percent (14) of the cost price of all tangible personal property transferred by said servicemen either in the form of tangible personal property or in the form of real estate as an incident to a sale of service, in accordance with the provisions of Section 8-11-5 of the Illinois Municipal Code.

Every Supplier or Serviceman required to account for SECTION 2. Municipal Service Occupation Tax for the benefit of this municipality shall file, on or before the last day of each calendar month, the report to the State Department of "evenue required by Section Nine of the "Service Occupation Tax Act", approved July 10, 1961, as amended.

SECTION 3. At the time such report is filed, there shall be paid to the State Department of "evenue the amount of tax imposed hereby.

The Village Clerk is hereby directed to transmit to the SECTION 4. State Department of Revenue a certified copy of this Ordinance not later than five (5) days after the effective date of this Ordinance.

This Ordinance shall be published within ten (10) days of its onactment as provided in Section 1-2-4 of the Illinois Municipal Code and shall be effective from and after the first day of October, 1969.

SECTION 6. This Ordinance shall be in full force and effect as above provided, and all ordinance or parts of ordinances in conflict herewith are hereby repealed effective as of October 1, 1969.
