AN ORDINANCE FIXING A FEE FOR SEWER CONSTRUCTION PERMITS IN THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

That there is hereby established a fee for the SECTION 1. connection of sanitary sewers with the trunks, lines or risers of the sanitary sewers of the Greater Peoria Sanitary District, in the Village of Bellevue, Illinois, which said fee shall be for ONE DOLLAR (\$1.00), for a permit and it shall show who the contractor is, what insurance he has protecting the Village from liability, and shall be based upon compliance with the rules, ordinances and regulations established, for openings made upon public property.

SECTION 2. Permit fees shall be paid to the Village Clerk and he shall issue the permit. All permits shall be posted on the premises where sanitary sewer connections are being made, and shall be in plain view so that the permit can be read from the road, street ornhighway.

Any person, firm or corporation who fails, refuses or neglects to procure and purchase such permit and comply with the rules and regulations established, shall be liable for a fine of not less than \$15.00 nor more than \$500.00, and each day that an offense continues, shall be deemed a separate offense and subject the violator to a separate fine; such fine may be recovered either in the prosecution or by cavil proceedings.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and publication as provided for by law, and it is ordered by the municipal authorities that this ordinance shall be publishe in pamphlet form, as provided for by law.
