ORDINANCE 280

AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TROUBLE THE VILLAGE
OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCH THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING ON JULY 1, 1982, AND ENDING ON JUNE 30, 1983.

WHEREAS, the Annual Budget and Appropriation Ordinance for the fiscal year was duly passed and adopted upon July 27, 1982, after a public hearing held thereon for which due notice was given for more than 10 days prior thereto, and not more than 10 days have elapsed since the adoption and publication of said ordinance, it is the duty of the President and Board of Trustees of the Village of Bellevue, to adopt the Annual Tax Levy for said Village of Bellevue, to meet and defray the necessary corporate expenses.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

That the following sum or sums, or so much thereof a may be authorized by law, be and the same are hereby levied and assessed against all of the properties that are subject to taxation in the Village of Bellevue, in order to raise the amounts levied for the General Fund, the Special Funds and the various funds herein levied as follows:

SECTION 2. That the amounts herein levied have been adjusted to deduct anticipated receipts from various sources, including the Corporate Resplacement tax, licenses and fines, anticipated to be received.

SECTION 3. That the total amount of the tax levied hereby is less than 105% of the amount levied or extended on the levy of the preceeding year, according to statutes in such cases made and provided.

SECTION 4. The County Clerk is hereby directed to extend a tax on all of the taxable property in this municipality to produce an amount as set forth in this levy and as sprovided by HB 1048.

SECTION 5. The Village Clerk is directed to file a certified copy of this ordinance levying the municipal tax, with the County Clerk of this County on or before the Second Tuesday in September of the current year.

SECTION 6. This ordinance shall be in full force and effect from and after its passage and adoption by the Board of Trustees of the Village of Bellevue, Peoria County, Illinois, and the approval by the Village President.

SECTION 7. All ordinances or parts of ordinances in conflict herewith are hereby repealled.
