## ORDINANCE NO. 286.

AN ORDINANCE PROVIDING THE METHOD FOR EXCAVATION BACKFILL AND PAVEMENT RESTORATION ON ALL IMPROVED STREET SURFACES, IN THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. The applicable portions of the laters edition of "Standard Specifications for Road and Bridge Construction" (Merein after called the Standard Specifications) shall govern the excavation, backfill and pavement restoration of any street or roadway with a flexible or rigid improved surface.

SECTION 2. The attached Standard Detail of Trench, Backfill and Pavement Replacement is made a part of this ordinance for guidance and compliance herewith.

SECTION 3. Whenever a trenching operation is located in the traveled portion of any street or readway the paving shall be saw-cut to a depth of la inches minimum on all sides of the excavation and the pavement shall be removed along the saw-cut lines. Pavement shall be sawed and removed so that the opening is at least 12 inches wide than the top of the trench on each side to prevent undermining. All excavations shall be backfilled with trench backfill or excavated material, meeting the requirements of Articles 703.01 and 703.05 of the Standard Specifications, to a depth just below the pavement Pavement replacement shall consist of restoration of the existing sub-base, base, and surface courses to the original crosssestion except that for flexible pavements a minimum 8" aggregate base course type B with a 3 inch bituminous concrete surface course will be required; and for existing rigid pavements a minimum replacement of 8 inch portland cement concreve payement, will be required. In the event that an existing rigid pavement with a bituminous overlay is encountered the minimum pavement replacement shall be 8 inch portland cement concrete payement with a bituminous concrete overlay matching the existing type and thickness. Payement removal and replacement shall conform to the applicable portions of the "Standard Specifications", and Section 619.

SECTION 4. Any failure to comply herewith shall result in the Village, without prior notice, to engage a contractor to remove and perform the fill work in a proper manner and the charges shall then be made against the bond or organization who made the original opening and no new opening permit shall be issued to any person, firm or organization until full compliance and payments has been made to cause the correction.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and the publication thereof in pamphlet form, and the same being published in pamphlet form, is now in full force and effect.
