Chairman Johnson, conversed with Mr. Merriman, that two owners now have not managed to fix viewable problems on property. The Village is wanting work completed on property. **Speaker**- Denny Merriman Sr.- Stated no. Mr. Merriman Sr., conversed that he felt that the Village is already dangling a carrot in front of them. That Bellevue, help create problem when they annexed neighboring property, into the Village of Bellevue. He stated that existing retention pond on neighboring property, was not correctly done.

**Speaker-** Employee, Zoning Officer, Matt Raible- Stated that business was built in Peoria County at time. Superintendent, Steve Wilson, has checked on water retention, after annexation and water retention plans were executed. Plans required were created by Engineer and retention pond upheld criteria required.

Speaker- Denny Merriman Sr.- Stated he would like a copy of engineering plans, for neighbor's retention pond. Mr. Merriman, Sr., stated neighbor would help with water drainage and Village should too. Would like the Village to help with problem? Mr. Merriman, stated he thought the Village, should issue license before work is done.

**Chairman Johnson**- Declared to Mr. Merriman, Sr., that he could contact neighbor of retention pond and request Engineered plans for retention pond.

**Speaker-** Denny Merriman, Jr.- Advise Board Members, that he grew up in Bellevue, and if he says he will complete the project and improve property, he will do just that. His word on property improvements could be trusted.

Village Attorney- Lane Alster- Advised Board Members, they could take request, by Mr. Merriman, Jr., for liquor license, to a vote.

Chairman Johnson- Advised the Board Members, that he feels the work should be done first and Mr. Merriman, Jr., should sign release. Chairman Johnson informed that video gambling and package liquor sales, do not meet criteria by state laws. Chairman Johnson stated after hole is filled in on Mr. Merriman, Jr., property the Village would issue a regular tavern license, to meet criteria for video gaming.
