AN ORDINANCE ACCEPTING A DEDICATION
OF RIGHT OF WAY FOR PUBLIC ROAD PURPOSES
(S. HAMPTONS COVE)

WHEREAS, A Dedication of Right of Way for Public Road Purposes ("Dedication") has been submitted to the Village of Bellevue by Krupps & O'Connor LLC, a copy of which is attached hereto, covering certain property within the Village of Bellevue described therein ("Premises"); and

WHEREAS, the President and Board of Trustees of the Village of Bellevue have determined that the best interests of the Village and its residents will be served by the acceptance of the Dedication;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

Section 1: That the Village shall accept the Dedication as evidenced by the execution thereof.

Section 2: That the President and Clerk of the Village are hereby authorized to evidence such acceptance by the execution of the Dedication and to take all other steps which are necessary and proper to effect such dedication.

Section 3: This Ordinance shall be in full force and effect from and after its passage as provided by law.
