AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING ON JULY 1, 1988, AND ENDING ON JUNE 30, 1989

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:
