AN ORDINANCE LEVYING AND ASSESSING THE CORPORATE TAX FOR THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING ON JULY 1, 1989, AND ENDING ON JUNE 30, 1990

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:

SECTION 1. That the following sums or sums, or so much thereof as may be authorized by law, be and the same are hereby levied and assessed against all of the properties that are subject to taxation in the Village of Bellevue, as follows:

SECTION 2. That the various amounts herein levied have been adjusted after deducting the anticipated receipts from various sources, including the Corporate Replacement receipts, License fees, Fine and other revenues likely to be received.

SECTION 3. That the total amount of the tax herein levied is less than 105% of the amount levied or extended on the levy of the preceding year.

SECTION 4. The County Clerk is hereby directed to extend a tax on all taxable property in this municipality subject to taxation, to produce the amounts set forth in this levy according to law.

SECTION 5. The Village Clerk is directed to file a certified copy of this Ordinance levying the municipal tax, with the County of this current year.

SECTION 6. This ordinance shall be in full force and effect from and after its passage and adoption by the Board of Trustees, and the approval thereof by the President of the Board.

SECTION 7. All ordinances or parts of ordinances in conflict herewith are, as to such conflict, repealed.
