AN ORDINANCE TO AMEND ORDINANCE NO. 341 REGULATING THE USE OF PROPERTIES WITHIN THE VILLAGE OF BELLEVUE, ILLINOIS (HOFFMAN)

WHEREAS, the Village of Bellevue has petitioned for and, at a meeting held pursuant to notice as provided by law, received the recommendation of the Village Zoning Commission for rezoning the property described on the attached Exhibit A, once annexed, from its zoning status upon annexation to the R-1 General Residential District classification.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: Ordinance No. 341 of the Village of Bellevue shall be amended so as to classify the subject property to the R-1 General Residential District classification.

Section 2: This Ordinance shall take effect and be in full force from and after its passage and publication as provided by law.

IRACI_1;

Part of the Southwest Quarter of Section Twelve (12), Township Eight (8) North, Range Seven (7) East of the Fourth Principal Meridian and part of Lots 37 and 38 in HANNA SZOLD'S SUBDIVISION of part of the Southwest Quarter of Section Twelve (12), Township Eight (8), Range Seven (7) East of the Fourth Principal Meridian, more particularly described as follows:
