**APPROVING AN AMENDMENT TO THE
VILLAGE OF BELLEVUE TAX INCREMENT FINANCING DISTRICT II

WHEREAS, the Village of Bellevue, Peoria County, Illinois by its duly elected Mayor and Village Board heretofore adopted a Redevelopment Plan and Projects; designated a Redevelopment Project Area; and adopted Tax Increment Financing pursuant to Illinois Revised Statutes Chapter 24, Division 11-74.4-1 *et. seq.* (now 65 ILCS 5/11-74.4-1) (the "TIF Act") known as the Village of Bellevue Tax Increment Financing TIF District II on July 14, 2005; and

WHEREAS, the Village of Bellevue, Peoria County, Illinois, desires to amend the Redevelopment Plan and Projects for its TIF District pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4 *et. seq.*, as amended; and

WHEREAS, subsequent to the formation of the TIF District the Village has entered into a Redevelopment Agreement to assist in the private redevelopment of properties within the Redevelopment Project Area for the benefit of the citizens of the Village; and

WHEREAS, the Village does not wish to add any new additional projects or costs to the Redevelopment Plan and Projects at this time; and

WHEREAS, the proposed Amendment does alter the exterior boundary of the Redevelopment Project Area by amending the Legal Description (page 7 of the Plan) and the Boundary Map (Page 10 of the Plan) by removing the parcel described in Exhibit 1 of this Amendment thus reducing the size of Bellevue TIF District II; and

WHEREAS, the proposed Amendment does make additional minor alterations to the Legal Description (page 7 of the Plan) in Exhibit 3 to conform to Exhibit 2 (Boundary Map);

WHEREAS, the proposed Amendment does not affect the general land uses established pursuant to the Redevelopment Plan; substantially change the nature of the Redevelopment Projects; increase the total estimated Redevelopment Project Costs set out in the redevelopment plan; add additional Redevelopment Project Costs to the itemized list of redevelopment project costs set out in the Redevelopment Plan; or involve the displacement of any households or inhabited residential units in the Redevelopment Project Area; and

WHEREAS, the proposed Amendment is consistent with the Plan and Projects and has been reviewed by the Mayor and the Village Board is generally informed of this Amendment.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND VILLAGE BOARD
OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS:**

1. The recitals set forth in the preamble to this Ordinance are hereby incorporated by reference as if fully set forth herein.
2. The Legal Description (page 7) and Boundary Map (page10) of the original Redevelopment Plan and Projects previously adopted with regard to Bellevue Tax Increment Financing District II is hereby amended to remove the parcel listed in Exhibit 1 of this Amendment and further evidenced by Exhibit 2 (Amended Boundary Map) and Exhibit 3 (Amended Legal Description) of this Amendment.
3. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law and shall take effect upon its passage as required by law.
4. All ordinances and parts of ordinances in conflict herewith are repealed.

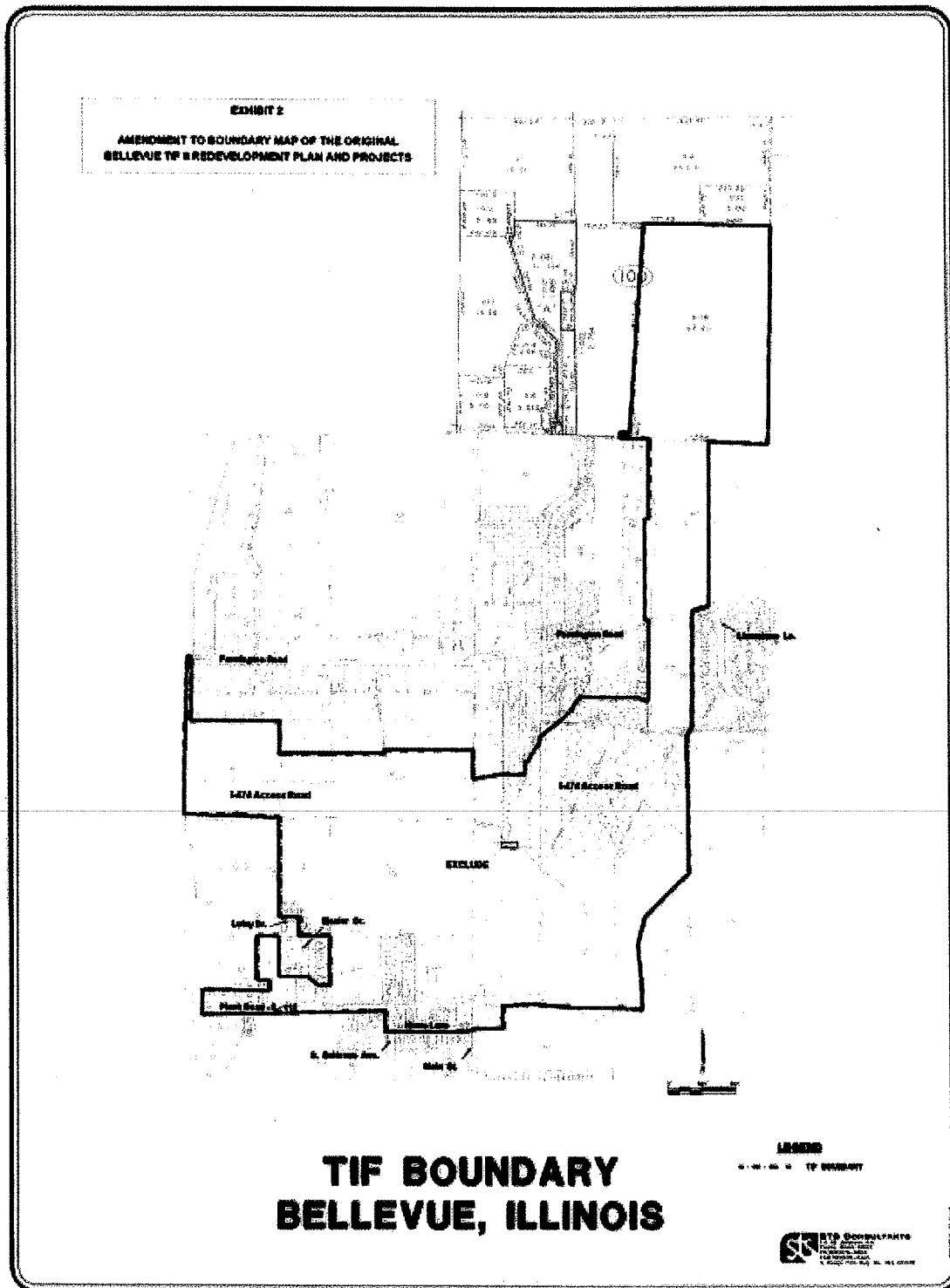

thence northerly along said westerly line to the southerly Right-of-Way line of said Illinois Route 116 (Plank Road);

thence westerly along said southerly Right-of-Way line to its intersection with the southerly extension of the west line of parcel having tax I.D. 17-10-253-003;

thence northerly on said southerly extension and the west line of said parcel having tax I.D. 17-10-253-003 to the northwest corner of said parcel;

thence easterly along the north line of parcels having tax I.D.s 17-10-253-003, 004, 018, 019 to the northeast corner of said parcel having tax I.D. 17-10-253-019;

thence southerly along the east line of said parcel having tax I.D. 17-10-253-019 to the southwest corner of parcel having tax I.D. 17-10-253-006;

thence easterly along the southerly line of parcel having tax I.D. 17-10-253-006 to the east line of said parcel;

thence northerly along the east line of said parcel to the north line of said parcel;

thence westerly along the north line of said parcel to a point on the west line of said parcel, said point also being on the west line of parcel having tax I.D. 17-10-253-008;

thence northerly along said west line of parcel having tax I.D. 17-10-253-008 to the north line of said parcel;

thence easterly along the north line of said parcel to the northeast corner of said parcel, said northeast corner also being the northwest corner of Lot 8 in Eisele Place;

thence southerly along the west line of said Eisele Place to the southwest corner of Lot 3 in said Eisele Place;

Dear Ralph:

Working with the county we have discovered some technical corrections that need to be made to the TIF II Map and Legal description. The legal description has errors such as referencing Tower Road instead of N. Tower Road, and needed other language to accurately follow the TIF II boundary. We were also informed by the County that a small parcel of land which lies along the southeast right-of-way for the I-474 access is not within the Village limits. Since the parcel is not within the Village limits, it cannot be in the TIF, so we are excluding it. Other than removing that parcel, the TIF II map is unchanged. The enclosed ordinance makes the necessary corrections and needs to be passed by the Board.

I have enclosed three ordinances and mailed a copy to Craig Hunziker for his review. Please put the ordinance on the agenda for your next Board meeting for passage. I ask that you and the Clerk execute all three copies, keeping one for the Village records and returning the other two to this office.

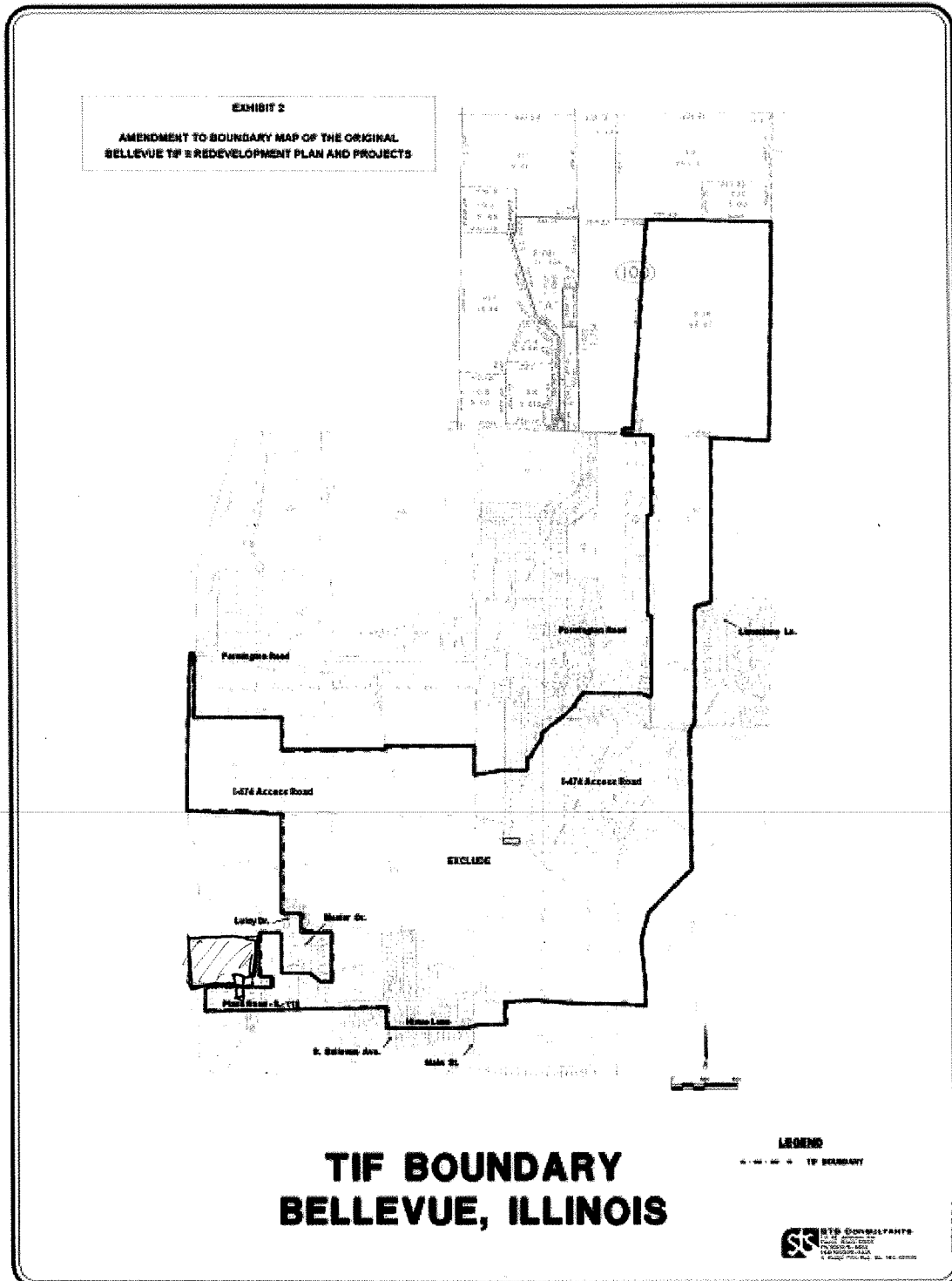
