ORDINANCE TO AMEND ORDINANCE NO. 573,
LIQUOR CONTROL ORDINANCE
(NUMBER OF LICENSES)

WHEREAS, the Village of Bellevue ("Village") Board of Trustees passed An Ordinance to Regulate the Sale of Alcoholic Liquor, Ordinance No. 573, on January 9, 2006 (hereinafter referred to as the "Liquor Control Ordinance"), such Ordinance regulating all aspects of the sale of alcoholic liquor within the Village; and

WHEREAS, Section 4-1 of the Liquor Control Act of 1934 (235 ILCS 5/4-1) authorizes municipalities to establish regulations and restrictions upon the issuance of and operation under local liquor licenses not inconsistent with law as the public good and convenience may require; and

WHEREAS, the Board has determined that the health and welfare of the citizens of the Village will be served by reducing the number of Class A liquor licenses that may be issued under the Liquor Control Ordinance from 3 to 2.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 2.4 of the Liquor control Ordinance, as amended, is hereby amended to reflect that no Class A license shall issue if such issuance will result in there being more than 2 Class A licenses outstanding.

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as is hereby authorized to be done by the President and Board of Trustees.


