ORDINANCE NO. 604

VILLAGE OF BELLEVUE, ILLINOIS ORDINANCE AUTHORIZING SALE OF REAL ESTATE BY PUBLIC BIDDING

WHEREAS, the Village of Bellevue Board of Trustees ("Board") is authorized by sections 11-75-1 and 11-75-2 of the Illinois Municipal Code to convey real estate owned by the Village;

WHEREAS, the Village President and Village Board of Trustees has determined that it is no longer necessary or useful to or for the best interests of the Village of Bellevue to retain the following described real property commonly known as 5726 W. Plank Road, Bellevue, Illinois now owned by it, which property is currently vacant:

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BELLEVUE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section One: The foregoing recitals are incorporated herein as findings of the Board.

<u>Section Two</u>: Pursuant to Section 11-76-1 of the Illinois Municipal Code, 65 ILCS 5/11-76-1, the Board finds that the herein described property, now owned by the Village, is no longer necessary or useful to the Village and the best interest of the Village will be served by the sale of the property.

<u>Section Three</u>: Pursuant to said Section 11-76-1, the Village President is hereby authorized and directed to publish public notice seeking bids for the herein described property pursuant to Section 11-76-2 of the Illinois Municipal Code, 65 ILCS 5/11-76-2. The aforesaid notice shall specify that the minimum bid will be \$30,000, and that the contract awarded will be subject to the following conditions: (1) the closing will occur within thirty days following the award of the contract; (2) the contract purchaser must pay cash at closing; and (3) the contract will not be subject to any contingencies regarding financing or any other matter.

<u>Section Four</u>: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
